Keynote Speaker Daphne Simpkins



Veteran caregiver and writer Daphne Simpkins has been writing about life in the South for about thirty years and sometimes those stories involved the adventure of caregiving for her father, who developed Alzheimer's. After publishing that first memoir about my caregiving experience The Long Good Night, I found I had something else to say about what the experience ultimately meant to me, and so I wrote What Al Left Behind, a short collection of essays about the changed perspective that AI (Alzheimer's) produces in the surviving caregiver." Her work has appeared in CAREGIVER magazine, The Chicago Tribune, The Christian Courier, The Christian Century, Evangel, The **Baltimore Sun, Tropic Magazine,** and dozens of other periodicals.

In addition to speaking about caregiving at churches, senior citizen centers and for various mental health organizations, Daphne has been a three-time speaker for the Alabama Assisted Living Association and is a member of the Alabama Humanities Speakers Bureau. She was named by **Mosaic Magazine** in 2013 as one of the five top speakers in the state of Alabama.
