

# Your Area Agency On Aging

■ The Lee-Russell Council of Governments Area Agency on Aging is part of a statewide aging network that provides a variety of home and community based services to seniors and those living with disabilities and their caregivers in Lee and Russell Counties.

The Lee-Russell Council of Governments (LRCOG) is pleased to serve and provide assistance and benefits to seniors and those living with disabilities and their caregivers in Lee and Russell Counties.

#### AGING AND DISABILITY RESOURCE **CENTER (ADRC)**

The Aging and Disability Resource Center assists seniors and individuals with disabilities, their families, and caregivers by connecting them to social service and health care resources. Individuals may work with an ADRC specialist in person or by phone.

The ADRC can help provide access to options such as counseling, long term care support, assistance with program applications and more.

#### **ALZHEIMER'S AND CAREGIVERS SUPPORT GROUP**

Monthly meetings for professional caregivers, family caregivers, and personal caregivers are provided for those who have loved ones with Alzheimer's disease, dementia, or other chronic diseases. The support group provides emotional support, information and education. Call 334-749-5264 for location and times.

#### **ALABAMA CARES**

Alabama Cares is a program designed to support family caregivers by providing training, assistance, and resources to help them take care of their aging loved ones and themselves.

#### **SENIORX**

Alabama SenioRx is a program designed to assist seniors with applying for free or discounted medications that are offered by pharmaceutical companies. SenioRx is also able to assist persons of any age that have received a letter stating that they qualify for disability and are in the waiting period of 24 months for prescription drug coverage.

If a person has prescription insurance in their job or has a Medicare Part D plan that does not cover the medication needed, or if the copay is too expensive, SenioRx can possibly help with that medication.

#### **OMBUDSMAN**

The Ombudsman investigates complaints and answers questions from residents and their families concerning care in nursing homes, domiciliary, and other long-term care facilities. This program is part of Alabama's continuing effort to improve conditions for seniors in long-term care facilities. The Ombudsman is available to help family members make decisions about long-term care. The Ombudsman is also available for

SHIP counselors are committed to helping Medicare beneficiaries make informed choices regarding insurance benefits. Counselors are not affiliated with any insurance company and will not attempt to sell insurance. All counseling records are strictly confidential.

#### **ELDERLY AND DISABLED MEDICAID WAIVER PROGRAM**

The Elderly and Disabled Medicaid Waiver Program enables eligible blind, elderly, and disabled persons to receive care in their homes and avoid or delay their move to an institution.

Elderly and Disabled Medicaid Waiver may provide:

#### T3 HOMEMAKER PROGRAM

Applicants must be 60 or older and need assistance with Activities of Daily Living. Applicants must be screened to receive assistance. T3 Homemaker services include light housekeeping.

#### **HOME DELIVERED MEALS**

Recipients of the Home Delivered Meals program must be at least 60 years old and homebound. Applicants will be screened by the agency to determine their qualification. The program provides frozen meals delivered weekly.

#### **TECHNOLOGY ASSISTED WAIVER** (TA WAIVER)

The Technology Assisted Waiver serves individuals who were receiving private duty nursing services through the Early Periodic Screening, Diagnosis, and Treatment Program upon turning 21 and for whom private duty nursing continues to be medically necessary based upon approved private duty nursing criteria.

TA Waiver may provide:

- Private duty nursing
- Personal Care/Attendant Services
- Medical Supplies
- Assistive Technology

#### SENIOR COMMUNITY SERVICE **EMPLOYMENT PROGRAM**

Senior Community Service Employment Program (SCSEP) provides subsidized, part-time employment opportunities in community service employment and training for low-income persons age 55 and older.



# Nutrition & Food Insecurity

■ There are many causes of food insecurity, especially in seniors on a fixed income. There are many organizations in the Lee-Russell County area that offer aid to help ensure access to enough food for an active, healthy life.

#### **PUBLIC FOOD ASSISTANCE IN ALABAMA**

#### **Supplemental Nutrition Assistance** Program (SNAP):

Formally known as the Food Stamp Program, SNAP offers nutrition assistance to eligible, low-income households, access to a healthy diet, education on food prep and provides economic benefits to communities. Recipients spend their benefits (provided on an electronic card that is used like an ATM card) to buy eligible food in authorized retail food stores. SNAP is the largest program in the domestic hunger safety net. The Food and Nutrition Service (FNS) works with State agencies, nutrition educators, and neighborhood and faith-based organizations to ensure that those eligible for nutrition assistance can make informed decisions about applying for the program and can access benefits. FNS also works with State partners and the retail community to improve program administration and ensure program integrity.

#### **Alabama Elderly Simplified Application Project (AESAP):**

AESAP is designed to reinvent the Food Assistance Program application process for those households where all members are elderly (age 60 or older), and have no earned income. This project is a major outreach effort to a segment of our population facing barriers to participation in the Food Assistance Program due to complexity of the application process and problems associated with age, such as transportation, mobility and disability. It is designed to increase the efficiency of the Food Assistance Program and improve delivery of food assistance benefits to eligible households by improving program administration.






